Scope

This questionnaire seeks to generate a profile of all those interested in being part of the panel of suppliers for the operations of Maurel & Prom in Venezuela ("M&P") that will allow us to perform a risk analysis and prevent acts of corruption and other related practices, determine legal compliance in the framework of applicable local and foreign regulations, as well as in the set of sanctions imposed that may pose a risk to M&P. In this sense, we need to have the information requested in this questionnaire to assess whether it is appropriate to initiate, continue or conclude business relations with your company (indistinctly, the "Company" or "Entity"). Therefore, your cooperation in this context is crucial. Please feel free to attach additional documents for any answers that require more space than is available in this questionnaire, as well as any supporting material.

Definitions

"Activity": Any acts, actions, undertakings, ventures, enterprises, projects, businesses, services, works or tasks related to projects in Venezuela, including, but not limited to, any activities or dealings with Venezuelan operations, suppliers, customers and agents, the export and import of goods or services to or from Venezuela, and any activities or dealings with the government of Venezuela, Petroleos de Venezuela, S.A., Petroregional del Lago, S.A., State legal entities or legal bodies, or state-controlled companies, and their respective subsidiaries, related parties, debts, equity or securities.

"Affiliate(s)": Any company that, at any time, the Company controls. In particular, (a) any company in which the Company controls, directly or indirectly, more than fifty percent (50%) of the capital stock or voting rights; (b) that such company controlled by the Company controls, in turn, directly or indirectly, more than fifty percent (50%) of the capital stock or voting rights of any other entity or any of its Affiliates; (c) the Company directly or through its Affiliates under (a) or (b) above, owns or controls less than fifty percent (50%) of the outstanding share capital, voting rights or the appointment of directors at a general meeting of such company (or any other entity), but in which such company or any of its Affiliates exercises supervision in the case of any other entity or any of its Affiliates.

"Company": The entity (e.g., corporation, partnership, limited liability company, joint venture) interested in being part of M&P's providers panel.

"Public Official": Should be understood in a broad sense and designates, but is not limited to, any elected or appointed official, employee or agent of any national, regional or local government, state or department, agency or subdivision of any government, state or corporation in which a government or state owns, directly or indirectly, a majority or controlling interest, an official representative of a political party, a candidate for public office and any officer, employee or agent of a public international organization.

"Close relative of a State Agent/Official": It shall be understood in a broad sense and designates, but is not limited to, a spouse or partner, children, brothers or sisters or parents, the spouse or partner of their children or of their brothers or sisters, or any member of the household.

"U.S. Person": U.S. citizens (including dual citizens); lawful permanent residents of the U.S. (e.g., U.S. green card holders), regardless of where they are located and regardless of whether they currently reside in the U.S.; and any person present in the U.S. (regardless of nationality and while in the U.S.) Entities are considered a U.S. Person if they are incorporated under the laws of the United States or operate in the United States.
